Eye Contact: If in eyes wash out immediately with water. In all cases of eye contamination it is a sensible precaution to seek medical advice.

SMALL SPILLS

LARGE SPILLS

7. HANDLING AND STORAGE

WES-TWA (Workplace Exposure Standard - Time-weighted average). The average airborne concentration of a substance calculated over an eight-hour working day.

WES-Ceiling (Workplace Exposure Standard - Ceiling). A concentration that should not be exceeded at any time during any part of the working day.

WES-STEL (Workplace Exposure Standard - Short-term exposure limit). The 15-minute time weighted average exposure standard. These Exposure Standards are guides to be used in the control of occupational health hazards. All atmospheric contamination should be kept too as low a level as is workable.
