4. FIRST AID MEASURES

6. ACCIDENTAL RELEASE MEASURES

SMALL SPILLS

LARGE SPILLS

Work up wind or increase ventilation. Remove all ignition sources and safely stop flow of spill. Bund area. Contain - prevent run off into drains and waterways. 
