4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

Inhalation: Remove victim to fresh air and keep at rest in a position comfortable for breathing. If respiratorysymptoms persist, get medical advice/attention. Apply resuscitation if victim is not breathing - Do not use directmouth-to-mouth method if victim ingested or inhaled the substance; use alternative respiratory method or proper respiratory device - Administer oxygen if breathing is difficult.
