## 4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

**Inhalation:** Remove victim from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.

**Skin Contact:** Wash with plenty of soap and water. Take off contaminated clothing and wash before re-use. If skin irritation occurs get medical advice.

**Eye contact:** Wash out immediately with fresh running water. Continue flushing until advised to stop by the Poisons Information Centre or a doctor, or for at least 15 minutes. Ensure complete irrigation of the eye by keeping eyelids apart and away from the eye and moving the eyelids by occasionally lifting the upper and lower lids. If pain persists or recurs seek medical attention. Removal of contact lenses after an eye injury should only be undertaken by skilled personnel.

**Ingestion:** Do NOT induce vomiting. Rinse Mouth. Give water to drink. Seek medical advice if symptoms occur.

## 6. ACCIDENTAL RELEASE MEASURES

### SMALL SPILLS

### LARGE SPILLS

Work up wind or increase ventilation. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). ## 7. HANDLING AND STORAGE

**Handling:** Avoid eye contact and skin contact. Avoid inhalation of vapour, mist or aerosols.

TWA - The time-weighted average airborne concentration over an eight-hour working day, for a five-day working week over an entire working life.

STEL (Short Term Exposure Limit) - the average airborne concentration over a 15 minute period which should not be exceeded at any time during a normal eight-hour workday.

## 10. STABILITY AND REACTIVITY
