### 4. FIRST AID MEASURES

#### **SMALL SPILLS**

### 10. STABILITY AND REACTIVITY

Chemical stability: Corrosive Liquid. Contact with alkaline material liberated heat.

Conditions to avoid: Elevated temperatures and sources of ignition.

**Incompatible materials:** Oxidising agents.

**Hazardous decomposition products:** HCL can liberate highly flammable hydrogen gas when in contact with certain metals.
